Scope of Registration

A foundation System which comprises a reinforced concrete slab supported on bored piles, driven piles, Vibro floatation, Vibro concrete columns, Engineered fill or stabilized ground. There are two basic types: Standard (deck supported from piles or treated ground, directly on the ground surface) and Voided (deck supported by piles, Void designed to accommodate ground heave and deal with gassing sites).

Conditions of Certificate

This Certificate covers Abbey Pynford's standard designs and procedures for the Housedeck product.

Special situations not covered by this certificate are as follows:

The Use of Fibre Reinforced Concrete Contaminated sites, where special precautions other than venting or membrane provision are required.

Ground Investigation Report including an interpretive report giving soil properties for pile design and heave potential of soil.

General arrangement plans for buildings being erected including proposed finish floor structural slab ground levels and details of drainage and services to building.
